ENTRY LIMIT:

Weeknights will be limited to approximately 5 hours of judging. Otherwise, until the 260 Maximum Run Value (see BHA club rulebook) per judge limit is reached or per current BHA rules in effect. Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly.

EXHIBITOR INFORMATION:

All dogs must be at least 6 months of age to compete in a Barn Hunt event.

All dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES MUST BE LOCKED SHORT AROUND OTHER DOGS/PEOPLE.

<u>Per BHA rules:</u> bark collars (including citronella, etc), head halters, uncovered prongs and muzzles are not allowed to be used on the trial grounds. <u>Dogs are required to run "naked" and should be brought into the ring with collars/harnesses/slip leads which can be easily and <u>quickly removed and replaced.</u> Please see page 9 section 13 of the competitor rulebook for further information regarding collars and leashes.</u>

FOOD:

There are numerous restaurants within 10 minutes of the trial. See welcome letter for more information.

CRATING:

There will be crating space available inside the building but please make sure your crate is secure as the dogs may be highly excited. Disruptive dogs will have to be crated outside of the covered trial area. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside the trial area. Please bring adequate shade.

IMPORTANT: Only soft or metal crates are allowed - no x-pens. All crates MUST have a tarp/blanket/towel/mat underneath them, between the crate and the matted flooring. Please be careful about water/food/etc spillage on the mats.

BITCHES IN SEASON:

Bitches in season are eligible to compete but will be required to be kept separate from all other dogs. They will be run at the end of their class/trial and <u>must wear pants</u>. If bringing a bitch in season, you must inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

REFUNDS:

Any entries pulled prior to pre-entry closing will be refunded minus any PayPal/Transaction fees. You must pull in writing (email or in person).

Any entries pulled after pre-entry closing will only be given a credit in the form of a voucher (minus a \$10 administrative fee per day) if there is:

- a) an entry on the waitlist that can take your spot (*refund issued minus admin fee)
- b) an injury to the entered dog, in which case a veterinary note may be required
- c) a death or hospitalization of an immediate family member, in which case a doctor's note may be required
- d) an emergency weather declaration (i.e. road closure due to weather, national weather emergency)
