Additional judges may be added to load balance, split, relief and/or backup judge.

Any of the Judges of Record for this event may be used to judge any of the classes at this event at the discretion of the Club under the rule provisions for Load Balancing, Relief Judging, and Splitting. Qualifying scores are assigned to the official Judge of Record for that class.

Permission has been granted by the Barn Hunt Association, LLC for the holding of these barn hunt trials under BHA Rules and Regulations.

Open to all Breeds and Mixed Breeds of all sizes! A Barn Hunt Registration Number IS REQUIRED to enter this trial.

Trial Opening Date: July 2, 2024. Entries received before this date will be destroyed. **Pre-Entry Closing Date:** July 30, 2024 or when entry limits are reached.

Late & day of show entries will be accepted for an additional fee if space allows. Late and Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

Any changes to your entry (besides move-ups) must be done in writing before closing! Please email Entries@RockyMountainRatters.com.

ENTRY LIMIT:

Until the 220 Maximum Run Value (see BHA club rulebook) per judge limit is reached or per current rules in effect. Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly.

CLASSES OFFERED:

Instinct, Novice, Open, Senior, Master, Crazy 8's. A&B Classes where applicable. Dogs may enter both the Instinct class and Novice class in the same Trial until the dog has earned the RATN title and then they cannot enter the Instinct class any longer.

* NEW: Competitors may enter more than one class type per Event (e.g. Open B on Saturday and Senior A on Sunday).

MOVE UPS:

*From another event can be made up until 24 hours prior to the start of the trial. Requests must be in writing. Email <u>Jen@RockyMountainRatters.com</u>.

*During the event if you title, you can move up to the next class for the next trial, except on the last day due to the running order. Move-ups must be submitted before the next class starts. * NEW: Competitors can move down to a lower level on a following day of trials. You must let the Trial Secretary know before the end of the trial day (or sooner) for the next day.

BLIND INFORMATION:

Blind will be at least 200 square feet, located at least 15' away from the ring. Instinct/Novice/Open will be blinds of up to 6 dogs. Senior & C8's will be blinds of up to 5. Master will be blinds of 4-5.

PRELIMINARY RUNNING ORDER: (subject to change based on entries):

Thurs-Sat: <u>Running up in levels</u> - Instinct (T1), Instinct (T2), Novice (T1), Novice (T2), Open (T1), Open (T2), C8 (T1), Senior (T1), Senior (T2), Master (T1), Master (T2), C8 (T2)

Sun: <u>Running down in levels</u> - C8 (T1), Master (T1), Master (T2), Senior (T1), Senior (T2), C8 (T2), Open (T1), Open (T2), Instinct (T1), Instinct (T2), Novice (T1), Novice (T2)

FEES: Pre-Entry (received on/before 7/30): \$20 Instinct Runs! \$28 N/O/S/M/C8's.

Late Entry & Day Of (received after 7/30): \$25 Instinct. \$33 N/O/S/M/C8s. If space and time permits, Late and Day of Entries will be accepted. Please bring a COMPLETED entry form with you to expedite your entry (you can pick these up at the trial site in advance). DOS must be submitted before the class prior to yours finishes. If you are in the first class, please come by 7:45am! We need to get you in the computer and cannot hold the start of the class. You can also register on a previous day. Credit cards accepted. CHECK THE WELCOME LETTER FOR CONFIRMED START TIMES.

HALF PRICE Entries for Junior Handlers (under 18 at the time of the trials)! *Please note on entry form if Junior Handler, include age. Must enter via paper form. No credits/refunds for handler changes after pre-entry closing. Additional fees will be due if dog is not run by a junior handler.

PRELIMINARY SCHEDULE: (check the welcome letter for confirmed times)

Trial Grounds will open at 7am each day. Briefing at 8am. Trials to follow briefing. Barn Hunt Trial Grounds will close no sooner than 30 minutes after the last dog of the day has run. Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

TRIAL GROUNDS:

On the outside of the arena, under the grandstands (North end) on concrete. Ring will be matted.

The trial will be held outdoors, under cover. Be prepared for hot weather! There will be no electricity supplied.

There are restrooms on site.

There is **NO SMOKING** in this facility or on the grounds. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

The trial will be held outdoors, with the ring on matted concrete.

HEIGHT DIVISIONS:

- Dogs 15" and under Small
- Dogs 15.1 to 22" Medium
- Dogs over 22" Large

WORKERS:

We need your help! We will need Gate Stewards, Rat Wranglers, Course Builders, Leash Runners, Scribes, and Sheet Runners. Information about each position is available at www.BarnHunt.com.

EXHIBITOR INFORMATION:

All dogs must be at least 6 months of age to compete in a Barn Hunt event.

All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED ON TRIAL GROUNDS.**

<u>Per BHA rules</u>: electronic collars, bark collars (including citronella,, etc), head halters, uncovered prongs and muzzles are not allowed to be used on the trial grounds. **Dogs are**

required to run "naked" and should be brought into the ring with collars/harnesses/slip leads which can be easily and quickly removed and replaced. Please see page 9 section 13 of the competitor rulebook for further information regarding collars and leashes.

FOOD:

There are also numerous restaurants within 10 minutes of the trial. See welcome letter for more information.

CRATING:

There will be crating space available outside. You can also set up canopies at your own risk. It will be HOT, bring fans etc. No electricity will be supplied. Disruptive dogs will have to be crated outside of the covered trial area. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside the trial area. Please bring adequate shade. Crating in the barn hunt area is for barn hunt competitors only.

BITCHES IN SEASON:

Bitches in season are eligible to compete but will be required to be kept separate from all other dogs and will be run at the end of their class/trial and <u>must wear pants</u>. If bringing a bitch in season, you must inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

REFUNDS:

Refunds/credits will be issued within 10 days of the completion of the event.

Any entries pulled prior to pre-entry closing will be refunded minus any PayPal/Transaction fees. You must pull in writing (email or in person).

Any entries pulled after pre-entry closing will only be given a refund minus a \$10 administrative fee per day) if there is an entry on the waitlist that can take your spot. <u>You must pull in writing</u> (email or in person) before 7 am on the day of the trial.

Entry fees will not be refunded/credited in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee or BHA.

Entry fees will not be refunded/credited in the event that a handler is ill or injured.

Entry fees will not be refunded/credited for bitches in season as they are eligible to compete.

Every attempt will be made to hold this event as scheduled. In the event of an "act of God' such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. Any refund of entry fees due to this will be made at our discretion.

AWARDS:

Qualifying ribbons will be awarded to all dogs with qualifying scores, including special Junior Handler ribbons.

Placement ribbons will be awarded to first through fourth place in each of the three height divisions for Novice A, Open A, Senior A, Master A, and Master B classes.

HIC rosettes will be awarded for Novice A, Open A, Senior A, Master A, and Master B classes.

Placement ribbons will be awarded to first through fourth place across all height divisions for Novice B, Open B, and Senior B classes.

C8 "Perfect Score", "Bonus" and "Super Bonus" ribbons will be available.

Perfect Event ribbons! Enter and qualify in all regular classes offered. For example, if there are eight trials offered, you'd need to enter all eight trials in your respective regular class level (Novice/Open/Senior/Master) and qualify in all eight.

Title ribbons will be available for all regular classes. For RATS and above, we will personalize your title ribbon!

Ribbons and labels must be taken on or before the last day of the trial (other than ribbons being personalized). Forgotten ribbons/labels will not be mailed.

Additional special awards may be offered at this event as well.

DIRECTIONS TO TRIAL SITE:


Island Grove Park - 11th Ave N & D St USE 11TH AVE

FROM THE SOUTH - From Hwy 85 take the 5th St exit & go west to 11th Ave. Proceed north on 11th Ave to park entrance.

FROM THE EAST OR WEST - From Hwy 34 Business Route take 11th Ave north to park entrance.

FROM INTERSTATE 25 NORTH OR SOUTH - Take Hwy 34 East to Business Hwy 34 exit, continue east to 11th Ave. Proceed north on 11th Ave to park entrance.
