#### Open to all Breeds and Mixed Breeds of all sizes!

A Barn Hunt Registration Number IS REQUIRED to enter this trial.

Trial Opening Date: April 12, 2022.

Entries received before this date will be destroyed.

**Pre-Entry Closing Date**: May 2, 2022 or when entry limits are reached.

\*\*Late & day of show entries will be accepted for an additional fee if space allows.\*\* Late and Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

Any changes to your entry (besides move-ups) must be done in writing before closing! Please email Entries@RockyMountainRatters.com.

#### **ENTRY LIMIT:**

Weeknights will be limited to approximately 5 hours of judging. Otherwise, until the 260 Maximum Run Value (see BHA club rulebook) per judge limit is reached or per current emergency rules in effect. Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly.

#### **CLASSES OFFERED:**

Instinct, Novice, Open, Senior, Master, Crazy 8's. C8 will be one per day on weekdays and two per day on weekends. A&B Classes where applicable

Dogs may enter both the Instinct class and Novice class in the same Trial until the dog has earned the RATN title and then they cannot enter the Instinct class any longer.

#### **MOVE UPS:**

\*From another event can be made up until 24 hours prior to the start of the trial. Requests must be in writing. Email <a href="mailto:Jen@RockyMountainRatters.com">Jen@RockyMountainRatters.com</a>.

\*During the event if you title, you can move up to the next class for the next trial, except on the last day due to the running order. Move-ups must be submitted before the next class starts.

#### **BLIND INFORMATION:**

Blind will be at least 10'x20', located 20' away from the ring. Instinct/Novice/Open will be blinds of up to 6 dogs. Senior & C8's will be blinds of up to 5. Master will be blinds of 4-5.

#### PRELIMINARY SCHEDULE: (check the welcome letter for confirmed times)

<u>Thurs/Fri</u>: Building will open at 5pm, Briefing at 5:30pm, Trials to follow. <u>Sat</u>: Building to open around 9am, Briefing at 9:30am, Trials to follow. Sun: Building to open around 8am, Briefing at 8:30am, Trials to follow.

#### CHECK THE WELCOME LETTER FOR CONFIRMED TIMES!! This is an estimate!

Building will close no sooner than 30 minutes after the last dog of the day has run. Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

#### TRIAL GROUNDS:

Barn Hunt grounds consist of the Matrix Dog training & event building.

There is an indoor restroom at the site.

There is **NO SMOKING** in this facility or on the grounds. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

The trial will be held indoors, on matted concrete. There is heating and cooling in the building but please dress appropriately for the outside weather. <u>Please feel free to bring fans, power</u> strips, extension cords, etc.

#### **HEIGHT DIVISIONS:**

- Dogs 13" and under Small
- Dogs 13.1 to 18" Medium
- Dogs over 18" Large

#### **VOLUNTEERS:**

We need your help! A Volunteer Sign-Up sheet will be on site. We will need Gate Stewards, Rat Wranglers, Course Builders, Leash Runners, Scribes, and Sheet Runners. Information about each position is available at www.BarnHunt.com.

#### **EXHIBITOR INFORMATION:**

All dogs must be at least 6 months of age to compete in a Barn Hunt event.

All dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES ARE NOT PERMITTED ON TRIAL GROUNDS.

<u>Per BHA rules:</u> electronic collars, bark collars (including citronella), head halters, and muzzles are not allowed to be used on the trial grounds. **Dogs are required to run "naked" and should be brought into the ring with collars/harnesses/slip leads which can be easily and quickly removed and replaced.** Please see page 10 section 14 of the competitor rulebook for further information regarding collars and leashes.

#### FOOD:

There are also numerous restaurants within 10 minutes of the trial. See welcome letter for more information.

#### **CRATING:**

There will be crating space available inside the building but please make sure your crate is secure as the dogs may be highly excited. Disruptive dogs will have to be crated outside of the covered trial area. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside the trial area. Please bring adequate shade.

**IMPORTANT**: Only soft or metal crates are allowed - no x-pens. All crates MUST have a tarp/blanket/towel/mat underneath them, between the crate and the matted flooring. Please be careful about water/food/etc spillage on the mats.

#### **BITCHES IN SEASON:**

Bitches in season are eligible to compete but will be required to be kept separate from all other dogs and will be run at the end of their class/trial and must wear pants. If bringing a bitch in season, you must inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

#### **REFUNDS:**

Any entries pulled prior to pre-entry closing will be refunded minus any PayPal/Transaction fees. You must pull in writing (email or in person).

Any entries pulled after pre-entry closing will only be given a credit in the form of a voucher (minus a \$10 administrative fee per day) if there is:

- a) an entry on the waitlist that can take your spot (\*refund issued minus admin fee)
- b) an injury to the entered dog, in which case a veterinary note may be required
- c) a death or hospitalization of an immediate family member, in which case a doctor's note may be required
- an emergency weather declaration (i.e. road closure due to weather, national weather emergency)

You must pull in writing (email or in person) before 7 am on the day of the trial. If you wish to re-enter another day with your voucher you will pay the current entry fee rate. TREAT VOUCHERS LIKE CASH. THEY WILL NOT BE REPLACED IF LOST.

Entry fees will not be refunded/credited in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee or BHA.

Entry fees will not be refunded/credited in the event that a handler is ill or injured.

Entry fees will not be refunded/credited for bitches in season as they are eligible to compete.

Every attempt will be made to hold this event as scheduled. In the event of an "act of God' such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. Any refund/credit of entry fees due to this will be made at our discretion.

## **RV CAMPING & PET FRIENDLY HOTELS:**

There is NO camping allowed on site. There are two RV parks within 15 minutes from the trial site.

## **IMPORTANT DIRECTIONS TO TRIAL SITE:**

Matrix Dog, LLC: 13720 Deere Court, Mead, CO 80504

From I-25 turn East onto Hwy 66. About .5 miles I-25 turn South onto Deere Court. Matrix is the last building on the left, and the middle unit. DO NOT park directly in front of the other units or block the garage bay doors. You can pull up to the building to unload and then parallel park on the dirt off Deere Court or along the back fence. After 5:30pm during the week and all day Saturday and Sunday the neighboring businesses in the building are closed and you can park in those spots.

#### AWARDS:

Qualifying ribbons will be awarded to all dogs with qualifying scores.

Placement ribbons will be awarded to first through fourth place in each of the three height divisions for Novice, Open, Senior, and Master "A" classes.

HIC rosettes will be awarded to "A" classes.

Placement ribbons will be awarded to first through fourth place across all height divisions for Novice, Open, Senior, and Master "B" classes.

C8 "Perfect Score", "Bonus" and "Super Bonus" ribbons will be available.

Title ribbons will be available for all regular classes. For RATS and above, we will personalize your title ribbon!

Ribbons and labels must be taken on or before the last day of the trial. Forgotten ribbons/labels will not be mailed.

Additional special awards will be offered at this event as well!





## Barn Hunt® Guide to A and B Classes



Beginning in the summer and fall of 2018, the Barn Hunt Association will start implementing B classes and a new titling track. These changes affect only the Regular classes of Novice, Open, Senior, and Master. The changes were made to give teams an opportunity to stay at a single level or move down to a previous level while also giving them an opportunity to achieve new titles at that level. Here is what you need to know about the new B classes.


- All dogs, regardless of handler experience, start in A class at each level and stay in A class until the dog attains the title at that level.
- Once a dog finishes a title from A class, that dog may either move UP to the A class at the next level, LAT-ERALLY into the B class at the same level, or DOWN to any previous level they are eligible to enter.
- In B classes, X titles are awarded after 10 qualifying scores. 10 qualifying scores in Novice B will be RATNX, 20 scores will be RATNX2, etc.
- There will be one set of placements for all competitors in each B class level, regardless of height.
- A dog may show in any class that dog is eligible for. So a dog with a Master title may move DOWN and show in Novice B, Open B, or Senior B.
- Dogs are not required to finish a particular B class title to move on from that class. A dog may have multiple qualifying scores from different levels and may choose to enter different B class levels at different events.

• Dogs are never required to enter any lower level B classes, but must enter Master B to attain the titles of RATCH, RATCHX, and above.

#### For each Event:

- All dogs must be entered in only one class level and type. (i.e., a dog cannot be entered in Novice B on one day and Open A on the next.)
- Dogs entered in B class must stay in that class for the entire event (may not move up or down during an Event.)
- Dogs maybe entered in one B class level one weekend and a different one the next. As an example, a dog with a RATM title could enter Master B on one weekend, then Open B the next, up to Senior B, then back to Master, etc.
- All existing Master scores and titles are grandfathered in to the B classes.

## TITLE PROGRESSION CHART



In the chart above, the A classes are listed on the far left. Next are the Qs needed to get the title at that level. Once you have the title the solid arrows show you where you can go next. For example, once you have your RATS title (gold box), you can follow the solid gold arrows to see that you can next enter either Master A, Senior B, Open B, or Novice B. Each X title takes 10 qualifying scores.
