BITCHES IN SEASON:

Bitches in season are eligible to compete but will be required to be kept separate from all other dogs and will be run at the end of their class/test and must wear pants. If bringing a bitch in season, you must inform the test secretary prior to the test and inform all exhibitors at the judge's briefing.

REFUNDS:

Any entries pulled prior to pre-entry closing will be refunded minus any PayPal/Transaction fees. You must pull in writing (email or in person).

Entry fees will not be refunded/credited in the event that a dog is absent, disqualified, excused or barred from competition by action of the Test Committee or BHA.
